02/17 Previous Minutes

The Minutes of the previous meeting, dated Wednesday 30th November 2016, were read and agreed as a true record.

03/17 Matters Arising

At the first executive committee meeting of the year (held on 22nd February 2017) no firm agreement was reached in Ann's absence as to how to proceed with the proposal re medals. It was recorded that: "A discussion on the subject did reveal a general feeling of favour towards medals but with some reduction in categories where appropriate. Support for plaques for multiple award winners was evident."

Given that the season was about to begin Ann subsequently decided to implement the proposal for the 2017 season. This is approved.

04/17 REPORTS FROM OFFICERS

GENERAL SECRETARY

Mike O'Gorman reported that one new club, Preston Park Youth CC, had joined during 2017. The system that had been implemented for processing affiliation renewals worked well. Approaches are to be made to Bognor Regis CC and Southborough & District Wheelers to see if they would wish to affiliate for 2018.

The report was accepted on a proposal by Steve Dennis and seconded by John Isard.

TREASURER.

Paul Thatcher had produced the audited accounts for 2017 and these were circulated with the Agenda.

A loss of £509.78 had been incurred for the year. The major expenses were engraving at £1,068.95 and Website costs at £320.89.

It was clarified that, as per the minutes of the February executive committee meeting, the website costs are for a two year period (*The Weebly licence (Pro Plan)* was renewed for a further two years up to 31 December 2018.at a cost of £155.78 (\$190). The UK2 licence was also renewed for 2 years up to 6 February 2019 at a cost of £157.32 (includes domain name of sussexca.org.uk), plus a payment of £6.49 for one year for domain name sussexca.uk.).

The Accounts were adopted on a proposal Mike O'Gorman and seconded by Jon Fry. A copy is appended to these minutes (Appendix 1).

TIME TRIAL SECRETARY

Steve Dennis reported on the Open Events promoted during the year and had provided a detailed written report. A copy is appended to these minutes (Appendix 2).

It was confirmed that the 25 remains on the G25/93 course. Ann Human pointed out that by CTT rules (rule 32) composite teams are not eligible for awards in team time trials. This will be taken into account for the 2018 2 Up Team Time Trial.

David Collard-Berry pointed out that if (as per proposals to the CTT National Committee) only category A event performances count for qualification then this might help as a selling point to boost the entry for the hill climb (see qualification for hill climbs is by prior positions rather than times).

The Time Trial Secretary's Report was accepted on a proposal by Peter Moon and seconded by Howard Bayley.

COMPETITION SECRETARY REPORT

09/17 PROPOSAL FOR CHANGE TO SPOCO COMPETITION SCORING

Mike O'Gorman had submitted a proposal (Appendix 3) to bring the scoring for the SCA SPOCO competitions into line with the SCA Championship Points competitions (by excluding non-affiliated riders from the list when determining points awarded.

This was passed (proposed by Howard Bayley; seconded by Jon Fry)

10/17 PROPOSAL FOR EQUAL PRIZE MONEY

Eastbourne Rovers CC (Les Jones) had submitted a proposal (Appendix 4) to award equal prize money for male and female riders at SCA events.

This debate took a very long time and was inconclusive. Part of the issue stemmed from people having different views as to what that meant.

Possible interpretations/options could be:

- An equal total prize pot for males and females.
- Equal numbers of prizes (e.g. first five male and first five female.
- Different number of prizes (equal prize money for identical positions). For example five male prizes, two female prizes with the money being identical for the top two positions.
- Different number of prizes (differing prize money for identical positions). For example five male prizes, two female prizes with the money being identical for the 'bottom' two positions as in female 2 receives the same as male 5 and female 1 receives the same as male 4.

The meeting simply ran out of time.

The proposal was 'approved in principle' by a vote of 6-3 (proposed by Steve Dennis, seconded by Jon Fry). It will be discussed further at the first committee meeting of the new year (this has been brought forward so that a decision can be reached before the season starts).

Proposed change to SPOCO scoring

Proposal: To bring the scoring method for the SPOCO competitions into line with that as used for the Points competitions

The current scoring method for SCA Points competitions excludes riders from non-affiliated clubs. So for the overall competiton the points are allocated from 30 down to 1 for the top SCA riders in our qualifying events events. This is mirrored in a 10 down to 1 scoring for the womens' competition. This is so that our Points competitions are not 'distorted' by the results of non-SCA affiliated riders.

In the SPOCO competition the points are allocated from 120 down to 1 but, unlike the Points competition, no allowance is made for finishing behind a non-SCA affiliated rider.

The disparity in approach appears illogical and confusing. The proposal is that as from 2018 onwards the scoring for the SPOCO competitions to exclude riders from non-affiliated clubs.

The proposed change is easily effected through simple spreadsheet formulae.

Proposal re SCA Prize Money

Proposal: To award equal prize money for male and female riders at SCA events.

At a recent Eastbourne Rovers Committee meeting the subject of equality of prize money for SCA events was raised by Marc Townsend. It was agreed that this should be raised for consideration by the SCA. The proposal is that male and female riders should be given the same prize money.

As Les Jones says: The question should be, "Is there a persuasive argument or rationale not to pay equal prize money". We are lagging behind with this one.

It is all about encouraging women and valuing them in our sport. It sends out all the wrong messages not to be equal in this area. We need to encourage women and show we are moving forward. It isn't big money and it would be a big gesture of equality in our local sport. The RideLondon Classics moved to equal prize money for men and women in 2016 (and so did Worthing Excelsior CC).

This is a supporting comment from a experienced local cyclist:

"Clearly an overall prize for a mixed event is unobtainable for women, so does nothing to encourage participation. The current prize structure almost places women in an inferior sub-category, their achievements not as worthy purely because they can't ride as fast.

Women deserve to have their efforts and achievements recognised and celebrated in the same way as men.

Currently some local TTs will only have a handful of female entrants, but why should that influence the level of reward? They have made the effort to enter, train and take part in the event, so should be recognised equally. Surely a fair solution would be to give equal prize money to the top 3 men and women.

There are nowhere near enough women taking part in our local TTs and we need to do things differently in order to start changing that. As cheesy as it sounds, do we want to be part of the problem or part of the solution!"
