# 09/15 PROPOSAL FOR 2016 COMPETITIONS

The proposal was to replace the current Sussex Championship Points Competition with the Sussex Points Competition to include all Sussex CA or Sussex championship events at set distances for solo riders, and also introduce a separate competition for women.

The proposal was accepted unanimously and takes effect for the coming 2016 season.

# 10/15 PROPOSAL FOR TEAM AWARDS FOR OPEN 25 MILE TIME TRIAL

Ann Human had prepared a proposal for consideration (and that can been seen as per item 09/15 above).

The proposal was to bring the team award for the 25 mile championship in line with all other championship events.

The proposal was accepted unanimously and takes effect for the coming 2016 season.

#### 11/15 ANY OTHER COMPETENT BUSINESS

Robin Johnson asked if there were any volunteers to do the presentations at Sunday's awards lunch but there were no takers.

David Collard-Berry kindly offered to help with the raffle at the award's lunch.

David Collard-Berry enquired as to whether any consideration had been given to creating and using any new courses in the area. The discussion revealed that some thoughts had been given but that due to traffic conditions and layouts it was becoming increasingly difficult to find anything suitable particularly at standard distances. The role of Highways England was also discussed in particular with regard to the conditions that they set for organisers (and to some degree how that conflicts with CTT Rules and Regulations), and the consequences of those conditions. There are doubts as to how much longer some of the standard distance G courses will be available for time trialling use.

The meeting reflected on the sadness felt by so many and the widespread sorrow and shock about Don Lock's tragic demise. Don had served on the SCA committee for over 20 years and his positive influence was felt by so many people. The outpouring of responses showed just how well he was regarded and across such a wide spectrum of people.
