The affiliation form has now been made available via the SCA website together with an online process to supplement this (and this has proved successful in completing the administration).

In Geoff's absence it was not known whether or not a trophy had been acquired for the new Ladies' points competition as agreed. Geoff to confirm.

David Collard-Berry returned the Junior BAR Trophy as held by Arthur Venables (he had won it in 2014, but had been replaced with a new trophy which was awarded to Jack Churchill last season). There was some confusion when it was described as the A.Patching Cup since that is supposed to be the senior Long Distance BAR Cup.
